- 1. Town Density (43 points)
  - Encourage growth in urban areas, focus housing growth (around municipal growth nodes), look at zoning changes to increase buildable land in towns, encourage growth in town via a more relaxed code or comparable code to the county & encourage the municipalities and county to work together to focus development in/around towns (make towns more attractive) (39)
  - Make living in town more desirable and affordable (4)
  - Make town feel more like country

  - Create incentives for growth in/near towns
  - Define rural
